
Housing for Older Adults

State of Aging in Central Indiana gives us key facts on housing:

- More than half of older adult renters in Central Indiana are burdened by housing costs, paying more than 30% of their income toward housing.
- In Central Indiana, 43% of Black older adults, 26% of Latinx older adults, and 24% of White older adult households (owners and renters) are housing cost burdened.
- 22% of Central Indiana's older adult households rent. The other 78% own their home. Among those homeowners, 41% have paid off their mortgage.

Half of older adult renters are burdened with housing costs.



Age-Friendly Communities

- Making communities more livable for people of all ages, especially older adults
- Multi-sector collaboration
- Homes designed or modified for aging in place
- Housing options that are suitable for differing incomes, ages and life stages



Pathways in Indiana

Hoosiers 60+ on Medicaid Aged & Disabled Waiver will transition to PathWays for Aging, launching July 1st

• Transition from a fee-for-service model to a managed care model focused on health outcomes

Enable recipients to age in the setting they prefer

- Currently 80% of spending is in care facilities, 20% in home and community-based settings
- Goal is to rebalance spending to 50/50

Plan now for the future

- Increase low-income housing options
- Universal design (ranches, ramps, wider doorways)



Lower-Middle Income Options

- As of January 2024, the Social Security Administration reported that the average **monthly social security check** is **\$1,907 per month**, which is about \$22,884 annual income.
- In 2024, HUD reports that the average **annual median income for Hamilton County is \$102,900**, which means seniors living on social security alone are about 22% of the AMI.
- The average cost of an independent, senior-living apartment in Hamilton County is approximately **\$3,000 per month**.
- Ideally, rent for low-income seniors on a fixed income would range from \$500-600 per month.

Lower-Middle Income Options



The average annual pension for a senior in Indiana is approximately **\$20,000** - which would make annual income with Social Security about **\$43,000**, which is closer to 50% of our AMI in Hamilton County.



Affordable units for seniors between the 50-80% of the AMI would range from **\$1,000 - \$2,000** per month.

Home Modifications & Repairs



9 out of 10 older adults want to remain in their home

Emergency Housing Options

Supervised Living Home:

For seniors that are independent, but may need companionship or supervision, the supervised home model could be a temporary solution.

Example of Supervised Living: Story Cottage in Carmel

Transitional Care:

Transitional care is offered by an assisted living or skilled nursing facility. They offer a certain number of beds on contract (usually based on a daily rate). They offer safe housing, as well as assisted or skilled care during the individual's stay.

Example of Transitional Care: Shalom Center at Hooverwood
