Established as a 501(c)3 tax-exempt organization in 2003, HAND's mission is to provide quality affordable housing and advocate for housing options where everyone can thrive. It owns 10 affordable rental communities with more than 150 apartments in Hamilton, Boone and Tipton counties.

HAND is the only state-designated Community Housing Development Organization (CHDO) in Hamilton County. Its 12-member board of directors provides oversight for a staff of three.

HAND properties are professionally managed by Herron Property Management.
